Licensing, Regulation and Alcohol Strategy Payment Options

There are several options available when making payment for an application for a licence or a licence renewal. Choose from those listed below for the one that best suits you.

All application payments are to be receipted through one of the Territory Business Centres via Darwin, Katherine, Tennant Creek or Alice Springs. Once this has been completed your application will be forwarded to the Licensing Officer in Licensing, Regulation and Alcohol Strategy for processing.

Cheque/ Money Order

Cheque or money order payments are to be made payable to the Receiver of Territory Monies (RTM).

Cash

Applications can be paid by cash however please do not send any money through the mail. Cash payments can be accepted at any of the Territory Business Centres listed below.

Credit

If you wish to pay by credit card you can complete a credit card authorisation form and include it with your application. Please note only Bankcard, Visa & Mastercard can be accepted.
